#### BY ENTERING THIS EVENT YOU AGREE TO BE BOUND BY THE WDBS STANDARD CONDITIONS OF ENTRY

**Dress code:** Collared shirt, waistcoat, trousers and smart shoes. A tie will be optional. If for any reason your disability means that this is not possible, please contact us to discuss this directly.

**Food:** Players and their supporters are kindly asked to support our host clubs and not to bring their own food and drink to venues.

**Lateness:** If you know that you are going to arrive late for the start of play on any day of the tournament, or for any match during the tournament, please contact the tournament director as soon as possible. Should we not hear from you, the tournament director reserves the right to enforce tournament rules, e.g. to dock frames in accordance with our rules of competition.

## **Disability Classification**

There are 36 individual WDBS profiles, grouped into eight classification groups.

Competitors must declare all prosthetics and sport specific aids when entering an event as it may change their group and/or profile. It should also be declared when requesting classification.

#### Group 6

WDBS aims to be as inclusive as possible and so does allow people that would not fit Paralympic/International Sports Federation for Persons with Intellectual Disability (INAS) criteria to compete in our events. In the interests of promoting fair competition we have therefore split Group 6 into two categories.

All Group 6 players must complete the our <u>G6 declaration form</u> before their first event.

#### Group 6A – open to players who meet all of the following three criteria:

- Evidence of IQ a full scale score of 75 or lower on a recognised and professionally administered IQ test
- Adaptive Behaviour OR Social Adaptation Evidence of significant limitations in adaptive behaviour a measure of how learning disability affects both daily life and the ability to

respond to life changes and environmental demands (Conceptual, social, and practical adaptive skills).

• Age of Onset Pre-18 years – must be able to show that the learning disability was evident before the person was 18 years old.

All participants in this group will be expected to have either their parent/legal guardian/carer/headteacher, or a recognised learning disability professional specialist, sign a declaration that the following will be provided upon request.

Participants also need to be aware that should they enter external competitions either endorsed or nominated by WDBS they will have to match criteria set by those governing that event.

#### Group 6B

- All players with a learning disability with IQ over 75.
  - Players with an IQ above 75 who have professionally diagnosed Autism Spectrum Disorder
  - Players with an IQ above 75 who have a developmental disorder please contact
     WDBS directly to discuss your eligibility
  - Eligibility for this group does not generally include players with an IQ above 75 who solely have Dyspraxia, Dyslexia or ADHD

Should entries for either 6A or 6B events be low for an event, either competition may be cancelled. WDBS will no longer hold combined events with players of both groups competing against each other.

All events staged by World Disability Billiards and Snooker (WDBS) are subject to the following Standard Conditions of Entry which are subject to change at the discretion of WDBS. **Please be reminded that all players are responsible for keeping WDBS up to date with their current email address.** 

**Entry Criteria:** All WDBS events are open to players of any age, gender or nationality, who fall within one of the <u>WDBS Classification profiles</u> included at that event. All entries are subject to board approval and WDBS reserves the right to refuse entry where appropriate.

**Entry/closing dates:** Entry fees (cleared funds) for all WDBS tournaments must be received together with a completed entry form (online or paper) by 4:30pm BST on the relevant closing date as set out within each tournament entry pack in order for your entry to be accepted into the event. Entry fees are non-refundable following the event entry deadline & payable via bank transfer or PayPal. Late entries may be accepted after the closing date at the absolute discretion of WDBS. Please note that if paying by bank transfer this may take a number of days so allow sufficient time for your payment to be transferred.

**Prize Money:** Prize money for each event is defined on the Event Entry Form or will be communicated to players either prior to or at the event itself. For payment to be paid directly into your account WDBS requires a completed bank nomination form from you. It is the players' sole responsibility to ensure WDBS has a completed up to date bank nomination form at all times, blank forms to be available at each event.

**Draw & Format:** Each event draw will be conducted by WDBS as soon as possible after the closing date of entry. The format is to be decided at the discretion of the Tournament Director and the WDBS board. Progression at tournaments will be determined in accordance with the <u>WDBS Draw Information Guidelines</u> in force at the time.

**Classification:** Events are open to players from specific <u>WDBS classification groups</u> as set out in the event entry pack. Classification is declared on a self-declaration process at the point of event entry. The WDBS board reserves the right to change a player's classification where this is appropriate or has been selected in error. Specific guidance relating to groups can be found within each event entry pack and on our website.

**COVID-19:** Players are strongly advised to read our latest COVID-19 guidance applicable to WDBS tournaments. WDBS reserves the right to withdraw a player from a tournament who displays COVID-19 symptoms.

**Dress Code**: Long sleeved shirt or blouse, fastened waistcoat & optional bow tie with trousers (not jeans) or skirt & shoes should be worn unless otherwise stated in the Event Entry Pack. We do NOT allow footwear including trainers, running shoes, sneakers, sandals, slippers, boots or playing with bare feet. The decision of the Tournament Director will be final in respect of Non-adherence to the Dress Code. Non-compliance with the Dress Code will result in a breach of the terms and conditions of entry for this tournament. For the avoidance of doubt WDBS may on the Tournament Director's discretion consider the appropriate sanction in this case MAY be withdrawal from the tournament without refund of the entry fee. The Tournament Director also reserves the right to report a player to the WPBSA for a breach of the dress code.

**Mobile Phones/Electronic Communication Devices**: Players are NOT permitted to use any mobile phones or other electronic communication devices <u>during the course of a match</u>, unless during permitted breaks of at least 15 minutes. Any player seen in breach of this by any WDBS

tournament official or referee will be reported to the Tournament Director and will be dealt with by the Tournament Director on conclusion of the match. The Tournament Director will then determine whether any sanction is required taking account of any mitigating circumstances. The only available sanction in this case to be at the discretion of the tournament director MAY be withdrawal from the tournament without refund of entry fee. The Tournament Directors decision will be final in respect of exceptional mitigating circumstances.

**Smoking/E-cigarettes**: Players are NOT permitted to smoke or use e-cigarettes <u>during the</u> <u>course of a match</u>, unless during permitted breaks of at least 15 minutes. Any player seen in breach of this by any WDBS tournament official or referee will be reported to the Tournament Director and will be dealt with by the Tournament Director on conclusion of the match. The Tournament Director will then determine whether any sanction is required taking account of any mitigating circumstances. The only available sanction in this case to be at the discretion of the tournament director MAY be withdrawal from the tournament without refund of entry fee. The Tournament Directors decision will be final in respect of exceptional mitigating circumstances.

**Coaching:** Coaching is not permitted during play. For the avoidance of doubt this includes between frames during the current session, unless during permitted breaks of at least 15 minutes. Any player seen in breach of this by any WDBS tournament official or referee will be reported to the Tournament Director and will be dealt with by the Tournament Director on conclusion of the match. The Tournament Director will then determine whether any sanction is required taking account of any mitigating circumstances. The only available sanction in this case to be at the discretion of the tournament Directors decision will be final in respect of exceptional mitigating circumstances.

### Grievances:

a. Should the Player wish to make any criticism or complaint or raise any grievance in respect of any matter relating to WDBS or its employees or directors, a Referee, Tournament, Director, Equipment, any of the Partners or any of the Venues at any time then the Player shall do so by:

i. Contacting the Referee for those complaints relating to Equipment or other item which affects the Player's ability to play snooker during a Match.

ii. Contacting the Tournament Director for those complaints arising during a WDBS Event.

iii. Contacting a board member in writing for any other complaint or grievance.

Any player found to have made public any grievance outside of the above options shall be reported to the Tournament Director. The Tournament Director will then determine whether any sanction is required taking account of any mitigating circumstances. At the discretion of the tournament director sanction MAY be withdrawal from the tournament without refund of entry fee and/or referral to the WPBSA.

**Social Media Guidelines:** Players are to be aware of the <u>WPBSA Social Media Guidelines</u>. Please note that a breach of the WPBSA social media guidelines is likely to be reported to the WPBSA disciplinary committee.

**WDBS Disciplinary Procedure:** In the event of any breach of these terms and conditions reported by the Tournament Director or any other party the WDBS Disciplinary Rules shall apply

**Roaming Referees:** If a dispute arises in a match where there is no match referee, either player has the right to call upon a roaming referee. In the event of there not being a roaming

referee either player has the right to call upon the senior referee. If neither available, either player may call the Tournament Director.

**Lateness:** Where a player arrives late for their scheduled match time, a frame will be docked at the scheduled start time. A second frame will be docked fifteen minutes later and then after every five minutes until the match is over. Regardless of the scheduled length of the match, once a player has been docked five frames the match is over.

**WDBS Events Rule Adaptations:** WDBS has introduced specific <u>WDBS Events Rule</u> <u>Adaptations</u> relevant for players with disabilities at WDBS events that will be enforced unless otherwise notified.

**Ranking Points:** WDBS Ranking Points are awarded in line with the latest ranking points schedules provided on our website. Points from historic events are removed in line with the latest re-ranking points document.

**Logos:** Players are permitted to wear up to four logos, to cover an area no greater than 6 square inches (38.7 square cm). WDBS reserves the right to apply brand exclusion on an event by event basis. This will be notified clearly within the entry pack for each relevant tournament where applicable. WDBS reserves the right to hold one logo place back for event title sponsor or WPBSA/WDBS partner, players to be notified in advance.

**Accommodation:** Each player is responsible for the payment of their hotel and expenses at WDBS events. If you request WDBS to reserve you a room with the host country, WDBS may assist in making a booking in the hotel/location, however following reservation, any changes, cancellation fees, early/late check in/out, travel to and from the airport are the responsibility of you the player unless agreed in advance by WDBS. WDBS will not be responsible for any charges incurred. If you do not pay for your hotel then this may be referred to the WPBSA who will have the right to withhold prize money to pay any outstanding charges.

**Cancellation/Relocation/Postponement:** If a tournament is cancelled, relocated or postponed entry fees will be refunded.

**Non-attendance:** In the event that you cannot appear at a tournament that you have entered you must inform WDBS as soon as possible as this will impact upon the draw. If you do not inform us you this will be considered a breach of the Event Conditions and MAY be subject to the WDBS Disciplinary Rules.

**Non-completion:** Players must complete all of their scheduled matches at events unless there are exceptional circumstances. If you do not complete your matches this will be considered a breach of the Event Conditions and MAY be subject to the WDBS Disciplinary Rules.

**Photo/Video Consent:** There are likely to be photographs and videos taken at WDBS events. WDBS may use such images for promotional material both at the current and future events and promotions across a number of media platforms.

**Data Use:** WDBS will use the information you provide on your event entry to contact you and provide updates e.g. email newsletters. You can unsubscribe at any time. View our <u>Privacy</u> <u>Policy</u> online.

**Presentations:** Medallists must be available to attend medal/trophy presentations if required by the WDBS, unless explicitly permitted not to by the WDBS.

Please note that from the date of entry to any WDBS event until 7 days after the conclusion of the event all players are bound by the <u>WPBSA Members Rules</u> and <u>Disciplinary Rules</u>.

The General Obligations under the Members Rules are:

1.1 Members shall, at all times (i.e. whether at a Tournament or not), behave in a proper and correct manner consistent with their status as professional player.

1.2 Members shall not do anything which is likely to intimidate, offend, insult, humiliate or discriminate against any other person on the grounds of disability, their religion, race, colour or national or ethnic origin, sex or sexual orientation.

1.3 A Member shall not make or cause to be made any statement or commit or cause to be committed any act which in the reasonable view of the WPBSA is likely to bring into disrepute the games of snooker and/or billiards.

1.4 Each Member shall participate in all snooker and billiards Matches, Tournaments and Tours in a fair and sporting manner and shall co-operate with WSL, WBL and the WPBSA to promote and develop the sports of snooker and billiards.

1.5 Members must comply with the entry terms and conditions of each Tournament in which they have entered.

1.6 Members will comply with and act in accordance with all reasonable instruction of the Tournament Director or any other Tournament Official.

1.7 Each Member shall perform and compete to the best of his ability in each Tournament in which she competes.

1.8 Members are responsible for their guests at Events. The Member may be held accountable for the Guest's behaviour regardless of whether the Member is with the Guest at the time of any inappropriate behaviour by the Guest.

1.9 The Board may from time to time supplement, amend or vary these Rules. Such changes shall be deemed to be effective and binding on each Member as from the date of publication of the changes.
